Students who fail to register for Fall 2015 courses by Friday, May 8, 2015 will be charged a \$50 Late Registration Fee and have a hold placed on their student account. This fee must be paid in full before you will be allowed to register for Fall 2015 classes.

## Summer Aid & Billing

For those who waited until the last minute to plan summer enrollment, you still have time to submit an application. View the information on how to apply for summer assistance at [http://www.canton.edu/fin\\_aid/summer\\_aid.html](http://www.canton.edu/fin_aid/summer_aid.html). Be sure to follow all steps including processing your summer bill. Keep in mind that summer financial aid eligibility is different than during the fall and spring semesters. Your summer bill must be paid in full or have approved/accepted financial aid to cover the balance or your summer courses will be dropped before summer term begins. Summer Sessions I and II begin on Monday, June 1 and Session III begins on Monday, July 6.

## Graduation

Congratulations to all those graduating this year! Students who borrowed a federal student loan will be mailed information to their permanent mailing address on how to complete their loan [exit counseling](#) online. This will assist you in understanding your debt, all the repayment options available to you, and when you have to start repaying your loan. Even though you are done taking classes we will still be here to assist you with any questions you have about the financial aid you received while attending SUNY Canton. Check that your mailing address in UCanWeb is up-to-date to prevent delays in receiving your mail. This is where we will send your diploma.

## Before you leave campus, did you do everything?

Take a final review of your student account before you leave for summer break. Clean out that email and submit any final outstanding requirements. Make sure you did all of your financial aid paperwork and that there are no holds on your account. Continue to monitor your SUNY Canton email account over the summer. Check that your mailing address in UCanWeb is up-to-date to prevent delays in receiving your mail.

Are you prepared to return in the fall semester? Be sure you completed the 2015-2016 [FAFSA](#) and follow up on any required paperwork. If you estimated any income on the FAFSA now is the time to update it. Check that your [NYS/TAP application](#) also has the correct college code (6010

for Bachelor Degree programs and 3010 for all others). We plan to create fall semester bills in late June so all financial aid paperwork should be complete before the bill is issued to avoid delays in processing. If you are switching from on-campus housing to off-campus, be sure you have submitted a [Housing Release Application](#) to the Residence Life Office in Mohawk Hall. Remember that the college has a mandatory housing policy and you must be officially released in order to live off-campus.

## Special Notice for Part Time Students

New York State Aid for Part Time Study (APTS) will be certified for the Spring 2015 semester after all final grades have been posted. Payment of these awards will be received over the summer break. [Part-time students](#) can now start applying for APTS for the 2015-2016 academic year, see eligibility guidelines and submit the application to the Student Service Center.

Additionally, any student who plans to attend part-time (less than 12 credits) during the Fall 2015 or Spring 2016 semester needs to notify the Student Service Center. Let us know the specific number of credit hours you plan to take each semester. We will double-check your aid eligibility (initial awards are based on full-time status) as well as the accuracy of your billed charges.

## Final Grades

Final grades will be available in UCanWeb after 2pm on Monday, May 11. At that point we will begin the financial aid satisfactory academic progress review. This is separate from the academic review. Students who fail to meet [satisfactory academic progress guidelines](#) will be notified by email and letter to the permanent mailing address on file. The notice will state if you are in danger of losing or have lost any financial aid eligibility for the next semester you attend SUNY Canton. The notice will include detailed instructions on your options.

## Federal Student Aid Change: FSA ID replaces the FSA PIN

On May 10, 2015 Federal Student Aid is changing the login process to all federal student aid websites. You will no longer be able to use the FSA PIN to log in as it is being discontinued. When you attempt to login after May 10<sup>th</sup> you will be directed to a link to register for your new FSA ID. The registration process should take just a few minutes. Keep your new FSA ID information in a safe place for future use.
