# HSMB Course Level Assessment Problems Identified - General

- Students were less successful with assignments requiring critical thinking and analysis of scholarly work in all courses. For example: Students fail to meet the minimum requirements of the grading rubric. They lack understanding of plagiarism or using credible sources.
- Students do not utilize, consistently, student support services. For example: Students often do not utilize the Writing Center or other tutoring/library support services.
- Students lack time management skills for submitting written work, specifically papers. For example: When target measures are not met, 90% of the time it is due to students not submitting assignments. This patter is especially noticeable in the second half of the semester. paper. In HSMB 307, specifically, only one of the course SLOs was met; the remaining four were not met because students who didn't submit their work were included in the findings

Data Driven Decisions How will the HSMB Program "Close the Loop" Data-driven decisions: How the department has or plans to "close the loop" based on these results.

- Given these findings, what will the department do differently?
- Five general categories:
  - Change teaching methods (HSMB 301, 302, 307)
  - Change the course curriculum (HSMB 306)
  - Increase instructional support (e.g., tutoring for HSMB 306)
  - Increase use of the writing lab and other library resources
  - Streamline the assessment

# What resources were used or have been requested to close the loop?

- Potential resources that you might identify:
  - Individual faculty time revising within a course
  - Department faculty time making revisions in teaching and assessment artifacts
  - Develop new course offerings
  - Course specific simulation software (\$1000)

# What changes to propose in the assessment process?

- Streamline the assessment:
  - Artifacts in multiple sections
  - Measures
  - Missing assignments
- Department discussion on how to better link course SLOs with program SLOs
- Professional Development (\$2000)
