    - More assignments in specific areas
    - Increased use of Blackboard Collaborate for scenario-based work

- Change teaching methods and text

to "close the loop" at course level

- Faculty time to make recommended changes to courses
- Blackboard Collaborate would be of no additional cost
- Possible textbook changes might be an increased expense to students, but not substantial

## Recommendations

- Encourage faculty who had outcomes "not met" to include recommendations for improvement
- Examine program SLOs where courses are having difficulty meeting outcomes
- Encourage faculty who did meet outcomes to also consider adjustments to assignments to better align with various department

programs

  - Curriculum Coordinator to review mapping of Outcomes and SLOs
  - Review findings to be ensure that all courses are relevant to LEL program
