SAFETY COMMITTEE CHARGE

The SUNY Canton Campus Safety Committee was established to address chemical hygiene issues. When Article 129-A of the NYS Education Law § 6431 was enacted, the Campus Safety Committee incorporated personal safety as well. The Committee is a presidential committee that functions outside faculty governance.

The charge of the Campus Safety Committee is to address a wide range of campus safety concerns. The Committee's first two charges are:

- 1. Responding to inquiries from concerned persons and referring complaints to the appropriate authorities, and
- 2. Recognizing, evaluating, and recommending a course of action to solve or control safety/health problems.

These two charges are met utilizing several different means. The annual Campus Safety Walk Around includes faculty, staff, and students who do a physical inspection of the campus during daylight and after dark. The <u>Safety and Health Reporting Form</u> is available to submit electronic safety/health issues. Finally, Safety Committee members are very active in soliciting and bringing safety issues to the Committee for discussion and resolution. Since a majority of the committee members are directly involved in the departments that play major roles in campus safety, most issues can be resolved at the committee level.

The Committee's last three charges are:

- 1. Ensuring that education is provided to the campus community about personal safety and crime prevention,
- 2. Identify and recommend strategies to the campus for the prevention of sexual harassment and sexual assault, and
- 3. Make recommendations for campus implementation by sharing them with the Title IX coordinator or designee.

These three charges are addressed through monitoring, reviewing, and participating in areas that provide safety information and education, including Title IX. Additional information has been included concerning Title IX and educational programming. As a part of its standing work, the Committee reviews a number of annual reports to assure compliance with the regulatory requirements, such as Campus Security Act, Fire Safety Report, Annual Campus Safety Report, and other requirements of the Education Law, Article 129-A

SUNY CANTON SAFETY COMMITTEE ACTIVITY SUMMARY

- Four Committee meetings were conducted for 2017-2018 year and the <u>Campus Safety</u> <u>Committee web page</u> is updated regularly.
- Reviewed mandatory compliance reporting for the <u>Jeanne Clery Disclosure of Campus</u> <u>Security Policy and Campus Statistics Act</u> and <u>Title IX</u> policies and reporting procedures.
- Thirteen campus-wide email notices were sent out on health and safety issues, including <u>Title IX</u> (3/30/18, 4/16/18), <u>Rave Alert</u> (10/26/17, 10/30/17, 1/23/18, 2/6/18, 5/4/18), <u>Elevated Water Level Warning</u> (5/4/18), <u>Heat Stress Alert</u> (8/2/17, 6/29/18) <u>Storm</u> <u>Warnings</u> (8/22/18, 4/4/18) and a <u>Solar Eclipse Warning</u> (8/14/17)
- Members of the Safety Committee conducted a Fire Safety Day on 9/21/17, which included fire extinguisher training, a sprinklered and unsprinklered mock dorm fire demonstration and fire safety house demonstration.
- Members of the Safety Committee conducted RA/RD Fire Safety Training including a classroom presentation, hands on fire extinguisher training, and smoke-the-corridor activity on 8/16/18.
- Members of the Safety Committee were involved <u>Rave Alert</u> notifiers meeting and training on 1/16/18, which was coordinated by the Public Relations Department.
- 2017 and 2018 Annual Campus Safety Walk-Around was conducted on 10/8/17 at 7 p.m. (Nighttime) and 4/24/18 at 2 p.m (Daytime). Fourteen new issues/areas of concern were identified, addressed, and followed up on.
- Reviewed and revised sections in the <u>College's Policies and Procedures Manual</u> and the <u>Student Handbook</u>.

TITLE IX

Amanda Deckert continues to be the Campus Title IX Coordinator. Farren Lobdell became the Deputy Title IX Coordinator in the Fall of 2017. At our October 10th 2017 Campus Safety Committee meeting, Campus Title IX Coordinator, Amanda Deckert gave the committee an update on Title IX activities. Many of the members on the Safety Committee are also involved in Title IX programs. Title IX, Sexual assault/harassment and domestic violence information is included in academic areas, such as First Year Experience (FYEP) 101 and BASK 060 (Freshman Seminar) by the Title IX Coordinator/Deputy Coordinator, Counseling staff, University Police, and Wellness Coordinator/Health Educator. Faculty and staff also completed mandatory online trainings for Preventing Sexual Misconduct (Title IX), Domestic Violence and the Workplace, Making our Campus Safer (Clery), and Preventing Workplace Violence. Title IX activities for 2017-2018 included:

- This summer, the NYS Office of Campus Safety initiated a comprehensive audit of 129-B Compliance. The audit requested a number of documents in a very short time period. All NYS Colleges and Universities were affected. This was the first time they have requested this type of data mid-year.
- Between Al Mulkin, Amanda Deckert, and Farren Lobdell we Title IX trained just over 850 students face-to-face during the Fall 2017/Spring 2018 semesters. This includes; Greek Organization leadership, all NCAA student athletes, RA's and student leaders and dorm programs as well as FYEP trainings.
- SUNY Canton is continuing the Green Dot initiative.
 - Green Dot had some media attention last fall with an article in the Watertown Daily Times, and a ¹/₂-hour web-show segment on North Country Matters.
 - Between action events and training, Green Dot reached over 1027 faculty, staff and students in the 2017-18 academic year spreading the Green Dot message.
- SUNY SPARC training- This has been put on hold because of Banner updates. We recently updated the Title IX WeComply training module to be move inclusive. We removed gender binary terms (he/she) and replaced them with more inclusive terms (they, their, them).
- We will continue to give Responsible Employee ID cards to all new faculty & staff These cards are pocket sized and give employees step by step instruction on what to say to a student if they disclose sexual assault, harassment, dating violence or stalking to you.
- Suzan McDermott, Director of Human Services; Al Mulkin, Chief of Police and Amanda Deckert are performing face-to-face training for all new employees and all current employees on Preventing Sexual Misconduct (Title IX), Domestic Violence and the Workplace, Making our Campus Safer (Clery), and Preventing Workplace Violence.

EDUCATION

There was a concerted effort to provide health and safety related programs to a wide audience in a variety of venues. Many of the Safety Committee members' departments are major providers of campus health and safety programs. Programs frequently addressed the intersection between domestic/sexual violence and alcohol/drug use. The following list highlights programs offered during the 2017-2018 academic year that addressed safety and health issues.

Counseling:

- Provided 1,683 counseling sessions.
- Responded to 56 crisis interventions.
- Presented/co-sponsored 224 educational programs this year with over 10,000 student contacts. Programs were presented to RA's, in the residence halls and several classrooms.

- Program topics included Beer Goggles Experience, Educational Jeopardy, Adult Coloring Therapy, Changing Perspectives, Weekly Meeting with Bill (using an AA meeting format) and Micro Aggressions training for RA's which is new this year.
- Awareness Tables/Campaigns for popular themes such as Spring Break Safety, Safe and Happy St. Patrick's Day, STI Awareness, and Make a Valentine Day Card, Alcohol Awareness, Sexual Assault Awareness, and Other Harmful Drugs Awareness.
- National Depression Screen Day was held in October 2017 with 80 individuals requesting screenings and many more gathering information and completing an art project.
- There was a Domestic Violence Awareness Silent Walk and Wear Purple Day during Domestic Violence Awareness week consisting of a "Mural on the Wall" project and an Awareness Table set up with Domestic Violence information in October 2017.
- Stress free programs were offered throughout the year in the dorms, classrooms, and commuter lounge and included bingo games, finals stress kits, and a Stress-Free Zone, massages by PTA students, ice cream donated by College Association, therapy stuffed animals and a visiting therapy dog named Thor.

- Green Dot Program consisted of 11 overview talks targeted toward student leaders including RAs, Athletes, SGA Senate and Greeks.

Student Activities:

- Helped the counseling center with the Stress Free Zone and provided finals kits for students during finals
- Helped fund therapy stuffed animals for students

Student EMS:

- Provides opportunities for students to volunteer as first responders or Emergency Medical Technicians (EMTs).
- Had a total of 71 Emergency Calls, 1 Standby, and 29 Transports to the hospital by Canton Rescue.

University Police:

University Police presented over 6 different educational programs in 30 forums with the goal of increasing safety awareness and a positive learning environment. The primary focus this year was once again Title IX, Sexual Assault, Dating Violence, and Civilian Response to Active Shooter Events training. Time was allotted in all programs for RAVE Notifier awareness. Students were all given opportunity to update their RAVE preferences with the assistance of UP. This programming took place in residence halls, FYEP, Kingston Theater and the Miller Campus Center. As a result, UP was able to deliver programming to almost 900 students, faculty, and staff.
