Last day to withdraw from Fall 2023

Attention Students:

Students have until **4PM on Friday, November 17**th to change their schedule. A \$20 Course Change Fee will be charged for each application submitted.

To withdraw from a single class, use the Course Change Request in the Registration menu in <u>UCanWeb.</u> See <u>detailed instructions here</u>. **MAKE SURE** that you go back in and confirm once you have received permission!

To withdraw from all classes, use the Request to Withdraw this Semester in the Registration Menu in <u>UCanWeb</u>. <u>See detailed instructions here</u>. You can indicate if you plan to return as a part of that process by requesting a Leave of Absence as well.

WinterTerm Registration



WinterTerm is an optional semester between fall and spring. You can choose to take a course or two in a condensed time to catch up or get ahead. All classes are online. Winter-Term dates are December 20th through January 18th. Discuss whether Winter-

Term is a good choice for you with your advisor. They can supply your registration code to sign up in UCanWeb. It may be possible to use your financial aid to pay for a winter course, but restrictions apply. See <u>Financial Aid for Winter-Term for detailed instructions</u>.

Spring Semester Registration

Spring 2024 Registration begins on November 13th. Make sure to meet with your advisor to discuss classes and obtain your Registration Code prior to the first day you can schedule classes on UCanWeb.

Utilize both the Worksheet and the Plans views in DegreeWorks to ensure that you are taking courses that help you make progress toward degree completion.

What is Changing?

Streamlined Application

Fewer questions when completing the 2024-2025 FAFSA and easier way to transfer tax information directly from the IRS.

Role-based Form

Individuals (student/parent/spouse) providing information on the FAFSA will see only questions related to their role.

Apply for an FSA ID

Everyone who will be providing information on the FAFSA will need a FSA ID to access the form.

FSA ID two step verification

Everyone using and FSA ID will go through a two-step verification process—set it up now!

Winter Term

Do you need to take a Winter class? Are you on track to graduate on time? Do you have academic progress issues?

WinterTerm can help you stay on track or even graduate early. This is a great time to make up credits, improve your GPA, or repeat a class to improve a grade. This is especially important if you are an Excelsior Scholarship recipient to help meet the 30 credits per year needed. Review the schedule of classes and talk to your advisor if you think a winter term class Is right for you.

Make sure you set up your account with BM Technologies to avoid delays in receiving your refund. More information on the overall refund process can be found at www.canton.edu/refund.




