

APA 7th EDITION CITATION: QUICK REFERENCE GUIDE

References: The reference list is placed at the end of the essay with a centered, bold heading (as shown below) and provides a list of all sources used. Entries are arranged alphabetically and double-spaced using a hanging indent. Please note we've used single-spaced text here to conserve space.

In-text (parenthetical) citations: In-text citations are placed in parentheses at the end of the quotation, clause, or sentence in which you mention the source material. They provide just enough info for the reader to easily locate the corresponding reference list entry and typically include the author's last name and the year of publication. Include page numbers, if available, for quoted material.

Book/E-book (always include DOI, if available, after publisher):

Book/E-book with two authors and edition other than the first:

Eschholz, P., & Rosa, A. (2011). *Subject & strategy: A writer's reader* (12th ed.). Bedford/St. Martin's.

Anthologized essay in an edited collection (list up to twenty authors in reference list):

Moore, P., Noonan, D., & Woodward, E. (2020). Juliana v. United States and the global youth-led campaign for a safe climate. In C. Henry, J. Rockstrom, & N. Book/E-book with editor:

Use sentence-case capitalization for titles of articles, books, book chapters, and webpages in the reference list.

In-Text Citations

Directly quoting? Include a page number.

(Patchett, 2016, p. 47)

(Eschholz & Rosa, 2011)

(Moore et al., 2020)

More than two authors? Use first author's last name followed by *et al.*

(Scherdin, 2014, p. 24, p. 26)

Use *p.* for non-consecutive pages and *pp.* for consecutive pages.

(Swasy, 2016, pp. 652-653)

Page on a website, no author named (start with title of webpage instead):

Page on a website with author (use retrieval date only if source is continuously updated, e.g., wikis):

Sparks, D. (2019, August 7). *Mayo mindfulness: Meditation is good medicine*. Mayo Clinic.

Page on a website with a group author (government agencies, associations, non-profits, businesses):

Centers for Disease Control and Prevention. (2018, January 23). *People at high risk of developing flu-related complications*. https://www.cdc.gov/flu/about/disease/high_risk

(Centers for Disease Control and Prevention, 2018)

When author name and site name are the same, omit the site name.
